**Purpose** The purpose of this award is to equip the learner with the

knowledge, skill and competence to explain and apply a limited range of physics concepts and principles within a supervised

environment.

## **Learning Outcomes**

Learners will be able to:

- 1 Define the SI units for work, power, and energy
- 2 Describe the different forms and sources of energy
- 3 Identify methods of heat transfer and insulation
- 4 Describe the sources and transmission of light to include, Speed, Spectrum, Colour, Dispersion
- Describe the characteristics of sound to include, Transmission, Speed, Reflection, Detection, Echoes, Hearing protection
- 6 Measure and record length, mass, time, volume, and temperature of various solids and liquids

- 7 Demonstrate the effects of force, friction, lubrication and gravity in everyday applications
- 8 Determine the factors affecting pressure in air and fluids
- 9 Identify examples of energy conservation
- Demonstrate the effects of heat on solids, liquids and gases
- 11 Demonstrate the applications of light reflection and refraction
- Demonstrate the application of communications, team working and quality awareness in a laboratory environment.

#### **Assessment**

### **General Information**

## Description

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

## **Guide to Level**

Learning outcomes at this level relate to a low volume of practical capability and of knowledge of theory. The outcomes relate to the performance of relatively simple work and may be fairly quickly acquired. Outcomes at this level may also confer a minimum employability for low skilled occupations and include functional literacy and numeracy.
