**Purpose** The purpose of this award is to equip the learner with the

knowledge, skill and competence to develop a limited range of

construction skills under supervision.

## **Learning Outcomes**

Learners will be able to:

- 1 List the tools, materials and equipment required to perform a limited range of construction skills under supervision
- 2 Maintain tools and equipment correctly
- 3 Identify construction career opportunities and their entry requirements
- Describe the process for constructing a brickwork panel taking account of brick types, mortar mixes and bonding
- 5 Construct a wood work project such as a work stool, or wall or floor mounted shelf unit, from partly preprepared material according to a given drawing

- 6 Complete a stud partition framework according to a given drawing to include construction of a stud partition, erection of the partition, and dry lining the partition on one surface with joints taped and filled
- 7 Fix skirtings and other timber trimmings according to a given drawing
- 8 Decorate wall surfaces and timber trimmings according to a given drawing to include painting and hanging wall paper
- 9 Hang a central heating radiator to include fitting and fixing pre- formed and cut pipework according to a given drawing
- 10 Apply the appropriate health, safety and personal hygiene procedures when working in a construction environment
- 11 Demonstrate the application of Communications, team working and quality awareness in a construction environment.

#### Assessment

#### **General Information**

## **Description**

#### **Skills Demonstration**

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. #### Grading

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning

outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

## **Guide to Level**

Learning outcomes at this level relate to a low volume of practical capability and of knowledge of theory. The outcomes relate to the performance of relatively simple work and may be fairly quickly acquired. Outcomes at this level may also confer a minimum employability for low skilled occupations and include functional literacy and numeracy.
