Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to use a range of personal and interpersonal skills in a variety of personal, civic and vocational contexts, operating with some autonomy while under direction.
Learning Outcomes	<p>Learners will be able to:</p> <ol style="list-style-type: none">1 Outline the principles of personal and interpersonal development2 Compile a range of personal qualities and skills appropriate to personal, civic and vocational contexts3 Explain the different types of relationships that occur in everyday life, to include their evolving nature, the impact of external factors on relationships, their portrayal in the mass media and some of the rights and responsibilities of individuals in their relationships with others4 Explain the concept of personal growth, to include key stages in the process, examples of experiences that provide an opportunity for personal growth, and

- source materials such as books, films, plays, papers or articles that bolster personal experience
- 5 Explore a contemporary social issue such as employment, unemployment, poverty, wealth, mental and physical health, racism or gender, to include the parameters of the issue, official and local or community attitudes and positions, treatment of the issue in the media and own personal response
 - 6 Outline the key elements of assertive, aggressive and passive behaviour in both individual situations and in a group or team, to include the use of assertive behaviour in rank and authority situations and the key features of responsibility in assertive behaviour
 - 7 Explore aspects of personal identity such as intellect, emotion and sexuality, to include ways in which these elements affect everyday life
 - 8 Express appropriate personal assertiveness skills in a range of familiar and unfamiliar contexts
 - 9 Use with confidence assertive boundaries in everyday life in personal, work and community contexts, to include dealing with adversity
 - 10 Reflect on an experience of personal growth, to include resources and qualities which the experience enhanced, how the experience benefited the learner and how the process of reflection can promote learning.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. In exceptional circumstances providers may identify alternative assessment techniques through the provider's application for programme validation which are **reliable** and **valid** but which are more appropriate to their context.

Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

Group or team work may form part of the assessment, provided each learner's achievement is separately assessed.

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and FETAC's assessment requirements.

Description

Portfolio / Collection of Work

A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Specific Validation Requirements	There are no specific validation requirements
Supporting Documentation	None
Access	To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.
Transfer	Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are

published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Independence is the hallmark of this level. Learning outcomes at this level correspond to a growing sense of responsibility for participating in public life and shaping one's own life. The outcomes at this level would be associated with first-time entry to many occupational sectors.
