**Purpose** The purpose of this award is to equip the learner with the

relevant knowledge, skill and competence to act as an effective member of a team, completing team-related tasks under instruction, while taking responsibility own activities and actions.

## **Learning Outcomes**

Learners will be able to:

- Describe the functions of teamworking, to include its advantages and disadvantages, and identification of different types of teams
- 2 Outline the contribution of an individual to a team
- 3 Identify personal strengths and weaknesses as a member of a team
- 4 Identify the principal elements and stages of team development, to include roles and impact of personality types
- 5 Assist in setting team objectives and ongoing evaluation of progress

- 6 Participate in core teamworking activities, to include listening to others, communication, problem-solving, finding solutions and conflict resolution
- 7 Demonstrate awareness of other team members ¿ ideas and opinions
- 8 Participate in feedback loops, ie giving and accepting appropriate feedback
- 9 Work effectively as a member of a team.

### **Assessment**

### **General Information**

The techniques set out below are considered the optimum approach to assessment for this component. Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

## Description

#### Portfolio / Collection of Work

A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.

### **Skills Demonstration**

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

# Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. ### 2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <a href="http://www.nfq-qqi.com">http://www.nfq-qqi.com</a>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see <a href="https://www.nqqi.ie">www.nqqi.ie</a>).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

### 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
