Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to actively participate in the dramatic process. It is designed to give learners group drama experience through the practice of a range of relevant dramatic skills and techniques, and to foster personal development.

Learning Outcomes

Learners will be able to:

- Discuss personal sensory perceptions of the environment
- 2 Describe different dramatic forms, conventions and roles within drama
- 3 Explain the elements of dramatic story making and telling
- 4 Demonstrate a range of physical and mental warm up and cool down relaxation techniques
- Use the body and the environment to enhance communications, dramatic expression and perception

- including light and dark, sound and silence, and human senses
- 6 Practice a range of voice techniques including breath control, voice control, speech and posture
- 7 Explore movement, movement in groups and nonverbal communication using different muscle groups, observation and mirroring
- 8 Use drama to explore a range of social environments and social situations
- 9 Practice varied forms of expression
- 10 Respond to a range of stimuli, including visual, oral, aural, musical, physical and tactile from other group members
- 11 Explore ideas and emotions through improvisation
- Participate in exploration, decision making, negotiation and compromise for a range of situations, using role play and improvisation
- 13 Explore roleplay including adopting a role, strategies used in the creation and development of role, and status, attitudes and values within roleplay
- 14 Examine the dynamic which affects group work through practical dramatic activity
- 15 Communicate an improvisation and a story on a given theme(s) with a beginning, middle and end
- 16 Review the presentation of the improvisation and story, including peer feed-back
- 17 Apply communication and team working skills when working in a drama environment.

Assessment

General Information

Description

Assignment

An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. 2. FET Award Standards

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
