Title Vehicle Brake, Oil and Battery Maintenance

Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to maintain and replace components associated with the brakes, battery, and oil system of cars and light commercial vehicles, whilst working under

supervision.

Learning Outcomes

Learners will be able to:

- Identify the correct personal protective equipment (PPE) for a range of tasks including brake and battery maintenance, and oil replacement, outlining the nature of the associated hazard
- Describe the function of the braking system of a motor vehicle including foot and hand brakes, and the characteristics of disc and drum brakes
- 3 Describe the procedure for handling damaged or refillable lead-acid batteries
- 4 Describe the principles of battery charging including battery construction and the action of the charger

- Outline the precautions necessary for the protection of vehicle audio, alarm, and management systems prior to battery disconnection
- Describe the major components of an engine is system including sump, filter, dipstick, sump plug, and identifying various types of engine oil and their characteristics
- 7 Use a range of equipment for vehicle elevation including lifts, jacks, and axle stands
- 8 Use both pneumatic and manual wrenches to remove and refit a wheel
- 9 Test the vehicle braking system including visual inspection of discs and drums, foot brake and handbrake function, and brake fluid level
- 10 Perform pre-charging checks including inspecting the battery terminals, inspecting the charger, and using testing equipment to assess battery performance
- 11 Perform oil-replacement pre-checks including assessing the condition and level of engine oil
- 12 Replace the brake shoes on a drum brake according to manufacturer¿s instructions
- 13 Replace the discs on a disc brake according to manufacturer; s instructions including handling the fluid and anti-lock braking systems, removing the discs, preparing the hub, fitting the discs, and reconnecting calipers and other disconnected components
- Recharge a vehicle battery taking all required steps to remove, charge, refit, and test the battery in accordance with manufacturer; s instructions
- 15 Replace the engine oil of a motor vehicle taking all required steps to identify the correct replacement oil, drain the oil reservoir, replace the oil plug washer, refit the plug, replace the oil filter, refill the oil to the correct level, and dispose of waste material appropriately.

Assessment

General Information

Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A

skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Examination - Theory

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Specific Validation Requirements

Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), http://www.nfq-qqi.com. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.nqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
