<b>Title</b>	Turning

<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to operate a center lathe to approved standards.
<b>Learning Outcomes</b>	Learners will be able to:  <ol style="list-style-type: none"><li>1 Explain the various parts of the centre lathe and their operations</li><li>2 Explain how the centre lathe is setup to produce production pieces</li><li>3 Apply safe working practices while operating a centre lathe</li><li>4 Interpret simple component drawings, including the following features: parallel and stepped diameters, drilled, reamed or bored holes, knurling (medium diamond) and chamfering</li><li>5 Prepare a centre lathe to produce production pieces, including the tools and equipment needed to machine parallel and stepped diameters, drill, ream and bore</li></ol>

- holes, cut medium diamond knurls, part off and face component
- 6 Operate a centre lathe to produce production pieces to specification, including machining parallel and stepped diameters, drill, ream and bore holes, cut medium diamond knurls, part off and face component
  - 7 Maintain the centre lathe, tools and equipment as per manufacturer's recommendations.

## Assessment

### General Information

<b>Access</b>	To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.	
<b>Transfer</b>	Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.	

## 2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see [www.qqi.ie](http://www.qqi.ie)).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Independence is the hallmark of this level. Learning outcomes at this level correspond to a growing sense of responsibility for participating in public life and shaping one's own life. The outcomes at this level would be associated with first-time entry to many occupational sectors.
