#### 1. Component Details

<b>Title</b>	Equine Hoof Care

<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to understand the basic principles of equine shoeing. It is designed to develop basic skills associated with the correct care of the equine's foot.
<b>Learning Outcomes</b>	<p>Learners will be able to:</p> <ol style="list-style-type: none"> <li>1 Describe the farrier industry in Ireland including governing bodies and types of insurance cover</li> <li>2 Describe the structure of the hoof including internal and external structures and the functions of major tendons and bones in the front and hind legs</li> <li>3 Explain the need for shoeing modern breeds of horses but not horses in the wild</li> <li>4 Explain the importance of good hoof care including procedures for picking out, supplements for promoting good hoof growth and hoof oil</li> <li>5 Outline the methods of counteracting the effects of hot weather and wet conditions on the hoof wall</li> </ol>

- 6 Describe a range of ailments, injuries, diseases and treatments of the hoof including puncture wounds, over reach and mud fever
- 7 Describe the functions of a range of the farrier's tools
- 8 Describe a well shod foot and the indications that a horse needs reshoeing
- 9 Describe correctly the removal of a horse shoe
- 10 Explain the difference between hot and cold shoeing
- 11 Describe the correct angle of the front foot, hind foot and hoof pastern axis
- 12 Describe the effect of flat feet and boxy feet on balance of the foot
- 13 Describe different types of horse shoe including plain stamped, aluminum racing plate and hunter shoe
- 14 Explain the different parts and features of a horse shoe including toe, quarters, heel, web, fullering, concave, rolled toe, calkin and wedge
- 15 Perform a range of practical skills safely and correctly when handling a horse including approaching, fitting a halter or headcollar and lead rope, tying up using a quick release knot, standing up for inspection, walking and trotting for inspection, and lifting and supporting a foot and holding a horse correctly for the farrier
- 16 Pick out feet correctly
- 17 Communicate effectively with clients.

## **Assessment**

## Description

### Assignment

*An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.*

### Skills Demonstration

*A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.*

### **Examination - Theory**

*An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.*

*A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.*

### **Recognition of Prior Learning (RPL)**

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. ### **Access**

## 2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
