> knowledge skill and competence to develop their skills in Gaelic Games and to be able to assist a Coach in the organisation of

activities to develop the games of Hurling and Football.

Learning Outcomes

Learners will be able to:

- 1 Outline the history of Gaelic Games and the basic Gaelic Athletic Association(GAA) club structure
- 2 Outline the range of current programmes available for skill development, adapted versions of the game and competitive levels in Hurling and Football
- 3 Explain the basic rules of full and adapted versions of Hurling and Football
- 4 Outline basic safety practices in the use of equipment in Gaelic Games
- 5 Identify the issues and challenges of working with different playing age groups

- Outline the implications of the GAA Code of Practice for dealing with young children
- 7 Identify the different types of games appropriate to Children, Youths or Adults, to include Fun Games, Modified Games and Full Games
- 8 Explain the role of the Coach and Assistant Coach, and how these roles may differ when working with different playing age groups
- 9 Explain the concept of Physical Literacy and the importance of movement and different types of movement within in Gaelic Games
- Outline the importance of the coaching skills of rapport, observation, analysis, explaining, demonstrating and providing feedback to players
- 11 Participate in drills and games to develop the basic skills and teamwork in Hurling and Gaelic Football
- Demonstrate safe practices in the use of equipment in playing Gaelic Games
- 13 Participate in modified versions of Hurling and Gaelic Football demonstrating a range of Gaelic Game skills
- 14 Apply the rules of Hurling and Football in a game situation
- Assist in planning, organising and managing players for an effective practice session
- Demonstrate appropriate communication skills in communicating with different playing groups
- 17 Assist in delivering a series of coaching sessions for participants to include movement, drills and fun games suitable for Children, Youth and Adult Participants
- 18 Plan, organise and run a Gaelic Games event.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. In exceptional

circumstances providers may identify alternative assessment techniques through the provider's application for programme validation which are **reliable** and **valid** but which are more appropriate to their context.

Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

Group or team work may form part of the assessment, provided each learner's achievement is separately assessed.

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and FETAC's assessment requirements.

Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. See RPL Guidelines at www.fetac.ie for further information and registration details.

Specific Validation Requirements

The Provider must have approval of the National Governing Body, The GAA, to offer programmes leading to this award.

Supporting Documentation

1. Supporting documentation is accessible via the National Governing Body www.gaa.ie.

Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), http://www.nfq-qqi.com. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.nqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
