#### 1. Component Details

<b>Title</b>	Sailing Skills
<b>Teideal as Gaeilge</b>	Scileanna Seoltóireachta
<b>Award Class</b>	Minor
<b>Code</b>	4N3647
<b>Level</b>	4
<b>Credit Value</b>	10
<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to safely and effectively sail an open sailing dinghy, keelboat or catamaran in light wind conditions without outside assistance.
<b>Learning Outcomes</b>	Learners will be able to:  <ol style="list-style-type: none"><li>1 Interpret weather forecasts for a specific location</li><li>2 Explain the Beaufort scale for wind speed</li><li>3 Locate tidal information for a specific location</li><li>4 Explain how wind and tides affect a chosen sailing location</li><li>5 Identify the parts of the boat and rigging</li><li>6 Identify the points of sailing</li><li>7 Describe what action to take in an emergency, to include: when caught under an inverted boat and summoning assistance afloat and ashore</li></ol>

- 8 Demonstrate the following skills:
  - Figure of eight knot
  - Round turn and two half hitches
  - Bowline
  - Clove hitch
  - Secure a line to a cleat
  - Coiling a line
  - Throwing one end of a line
- 9 Prepare a sailing boat and crew to go afloat
- 10 Launch and recover a sailing boat from a beach or slipway
- 11 Paddle row or scull a boat around a triangular course
- 12 Sail the boat across the wind, upwind and downwind
- 13 Demonstrate an awareness of the basic rules of the road and react appropriately when meeting other craft
- 14 Bring a sailing boat alongside, secure to and then leave a pier, pontoon and moored boat
- 15 Pick up, secure to and leave a mooring buoy
- 16 Anchor the sailing boat, weigh the anchor and leave
- 17 Recover and care for a man-over-board
- 18 Recover a capsized boat and sail away.

## **Assessment**

### **General Information**

## Description

### Skills Demonstration

*A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.*

**Recognition of Prior Learning (RPL)**

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. **Specific Validation Requirements**

The provider must have all of the following in place to offer this award: The Provider must have approval of the National Governing Body, The Irish Sailing Association, to offer programmes leading to this award.

**Access**

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

**Transfer**

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

**2. FET Award Standards**

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see [www.qqi.ie](http://www.qqi.ie)).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

### 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
