Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to orienteer in urban areas such as parks and small woods and partake in public orienteering events.
Learning Outcomes	<p>Learners will be able to:</p> <ol style="list-style-type: none"> 1 Explain the role and organisational structure of orienteering in Ireland 2 Explain the main components and layout of the orienteering map 3 Identify the main differences between orienteering maps and Ordnance Survey maps 4 List the personal equipment required when participating in urban, forest and open mountain events 5 Explain the use of colours and the features they represent on the map and on the ground

- 6 Demonstrate an understanding of route choice, relocation, orientation and scale
- 7 Orientate a map using ground features and a variety of compass types
- 8 Demonstrate the first principles of route choice selection by using decision points, checking points, handrails and taking a control
- 9 Illustrate how features on the landscape are symbolised on the map
- 10 Calculate distance from the map to the ground and from the ground to the map
- 11 Demonstrate preparation for a race by selecting the proper personal equipment, physically warming up and becoming familiar with the course
- 12 Demonstrate the ability to independently register for a public orienteering race, start a race, collect all controls and finish
- 13 Optimise route choice by using feature collection and confirming position at each stage of the route
- 14 Demonstrate basic health and safety appropriate to the outdoor environment to include, assessing the situation, assessing a casualty, calling for help and promoting recovery
- 15 Show an awareness of the effects orienteering may have on the environment.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. In exceptional circumstances providers may identify alternative assessment techniques through the provider's application for programme validation which are **reliable** and **valid** but which are more appropriate to their context.

Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

Group or team work may form part of the assessment, provided each learner's achievement is separately assessed.

All providers are required to submit an assessment plan as part of their application for programme validation. Assessment Plans will include information relating to scheduling and integration of assessment. See current FET validation guidelines at www.qqi.ie.

Assessment Techniques

In order to demonstrate that they have reached the standards of knowledge, skill and competence identified in all the learning outcomes, learners are required to complete the assessment(s) below.

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and FETAC's assessment requirements.

Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)	Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. See RPL Guidelines at www.fetac.ie for further information and registration details.

Specific Validation Requirements	The provider must have all of the following in place to offer this award: The provider must have the approval of the National Governing Body, the Irish Orienteering Association to offer programmes leading to this award.	
Supporting Documentation	1. Supporting documentation is accessible via the National Governing Body, the Irish Orienteering Association.	
Access	To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.	
Transfer	Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.	

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Independence is the hallmark of this level. Learning outcomes at this level correspond to a growing sense of responsibility for participating in public life and shaping one's own life. The outcomes at this level would be associated with first-time entry to many occupational sectors.
