<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to understand and appreciate Irish folklore and ethnology and to gain practical skills in ethnological collection and presentation.
<b>Learning Outcomes</b>	<p>Learners will be able to:</p> <ol style="list-style-type: none"><li>1 Explain the concerns, scope and nature of the discipline of folklore and ethnology in Ireland</li><li>2 Identify specific theoretical perspectives which govern the assimilation and interpretation of different manifestations of Irish culture</li><li>3 Explore how folk belief systems were born from and functioned within the specific socio-economic circumstances of 19th and early 20th century Ireland</li><li>4 Interpret folk belief, custom and ritual in Ireland, specifically relating to calendrical and individual time</li><li>5 Appreciate the connections between Ireland's ancient mythological past, Christian reinventions and</li></ol>

vernacular reflexes in respect of individuals, customs and events

- 6 Explore Irish material culture in the vernacular tradition between 1700-1950
- 7 Assess the concerns and problems associated with the curating and conservation of different types of traditional material culture

- 9 Explain the challenges and strategies faced by organisations and institutions involved with ethnographic and folk life curation and presentation
- 10 Identify the main categories under which the main corpus of Irish oral literature is organised
- 11 Outline the numerous social contexts and reasons for both variation and conservation in popular oral literature in Ireland
- 12 Describe significant contemporary exponents of the oral tradition in the Ireland of today
- 13 Select published and unpublished, primary and secondary sources and suitable informants on which to conduct research
- 14 Present research material in a range of formats
- 15 Use digital cameras, recording devices and other technical equipment
- 16 Implement best practice in conducting ethnological research, collection, interpretation and presentation
- 17 Interpret visual and audio-visual source material, extrapolating data to augment other text-based research data
- 18 Evaluate personal research material in light of other ethnological interpretation
- 19 Evaluate work produced considering objectives, planning and time management.

## Description

### Project

*A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may*

*involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.*

### **Examination - Theory**

*An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.*

*A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.*

### **Examination - Practical**

*An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.*

*A practical examination assesses specified practical skills demonstrated in a set period of time under restricted conditions.*

### **Recognition of Prior Learning (RPL)**

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. ## 2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
