**Purpose** The purpose of this award is to equip the learner with the

knowledge, skill and competence to capture and produce trade processed colour and black and white prints using a 35mm SLR

camera.

# **Learning Outcomes**

Learners will be able to:

- 1 Explain different camera types including compact digital and 35mm SLR digital cameras
- 2 Define a range of photography concepts, including lens aperture, shutter speed, depth of field, focus and ISO sensitivity
- 3 Explain the interrelationship between lens aperture and shutter speed
- 4 Use a digital SLR camera to capture images
- 5 Use additional camera accessories including lenses, portable flash units, and camera supports

- Take a series of photographic images that show image sharpness, tone and depth
- 7 Use different camera settings including both long and narrow depth of field and both fast and slow shutter speeds
- 8 Operate in a professional manner with individuals and groups in photography related settings
- 9 Respond to timelines and deadlines within a range of photographic settings
- 10 Evaluate work produced considering objectives, planning and time management.

#### **Assessment**

#### **General Information**

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. In exceptional circumstances providers may identify alternative assessment techniques through the provider's application for programme validation which are **reliable** and **valid** but which are more appropriate to their context.

Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

Group or team work may form part of the assessment, provided each learner's achievement is separately assessed.

## Description

# **Project**

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

#### Portfolio / Collection of Work

A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.

## **Learner Record**

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Minimum 3000 words.

# Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. #### 2. FET Award Standards

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

#### 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
