Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to use colour and natural and artificial light together in a range of design contexts for practical

and expressive purposes.

Learning Outcomes

Learners will be able to:

- Outline with some depth, principles of colour and light theory
- Evaluate key factors influencing the development of traditions in using colour and light, including economic, technological, scientific, aesthetic, sociological etc
- Recognise the psychological effects of colour and light, including in the creation of mood, atmosphere
- 4 Use the vocabulary and terminology of environmental design, creative use of natural and artificial light and colour applications in a range of specific environments, including interior design, stage setting, and window display

- 5 Critically analyse historical and contemporary developments in colour and light when used in the built environment
- 6 Use colour with natural and/or artificial light together to express concepts or mood and to resolve challenges of a variety of external and internal environments
- 7 Present a colour and light scheme with the aid of illustrative and presentation sample boards
- 8 Identify a range of colour and light products that are readily available
- 9 Establish a process of working using personal ideas, primary and secondary research to provide as strong basis for the development of a range of responses to briefs
- 10 Use technical craft and design skills to visually express personal ideas and interpretations of concepts and the observed world
- 11 Demonstrate responsible practice with regard to health, safety and environmental practices
- 12 Demonstrate critical awareness of own and others work.

Assessment

General Information

Portfolio / Collection of Work

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), http://www.nfq-qqi.com. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.nqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated

authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
