Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to plan and produce a range of menus taking into account nutritional requirements, special

dietary needs and current nutritional trends.

Learning Outcomes

Learners will be able to:

- 1 Describe the influences of tradition, culture and trends on food choice and menu planning
- 2 Explain key nutritional influences on contemporary menu design
- 3 Describe a range of different types and styles of menus and their uses
- 4 Describe the role of ethics in menu planning
- 5 Explain how menus and dishes are constructed, and the role of variety, balancing ingredients, flavours and textures
- 6 Describe the role of the menu as a marketing tool

- 7 List the principal nutrients in food, for example: proteins, lipids and carbohydrates, and the general features, functions and food sources of each
- 8 List the energy values of the different food types
- 9 Describe how natural foods are processed and the effects of processing on the properties of the foods
- Explain how stages in the food preparation cycle affect the stability and overall nutritional content of food
- 11 Describe the effects of additives and supplements in food
- Outline common food allergies and intolerances, identifying ingredients relevant to these
- 13 Explain the use of ingredients in a range of dishes and the role of labeling in food products as a source of dietary information
- 14 Understand the role of nutrients in relation to diseases, including obesity, heart disease and cancer
- 15 Identify a comprehensive range of dishes to meet special dietary needs and reflect current dietary trends
- 16 Compile a range of menus to suit different types of meals for different categories of consumers
- Outline the current and future role of genetically modified, irradiated, functional, organic, biodynamic and whole foods.

Assessment

General Information

Description

Project

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

Examination - Theory

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. 2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
