Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to incorporate a social justice dimension into their work with their specific target group.
Learning Outcomes	<p>Learners will be able to:</p> <ol style="list-style-type: none">1 Summarise the core principles that underpin all social justice work to include the similarities or differences between each core principle, best practice in the relevant sector and which, if any, of the core principles are embedded in the organisational context of a particular organisation2 Discuss social justice issues impacting specific groups within local communities and wider society3 Examine the wider connections of the identified social justice issues4 Comment on how politics, economics and technology have historically contributed to current inequalities experienced by specific groups in society

- 10 Analyse the range of social actions to include their impact
- 11 Identify power structures and the individual potential to influence these to include the role of self empowerment in creating the potential to address social justice issues
- 12 Illustrate how the incorporation of a core principle into an organisation could enhance the quality of opportunities offered for the target group
- 13 Use a range of terminology and vocabulary used in social justice work
- 14 Express a personal perspective on a social justice issue to include the values and attitudes informing that view
- 15 Apply methods to agree, measure and recognise the achievements of a specific group of people involved in social action
- 16 Implement best practice as part of a social justice programme, while addressing social justice issues with specific target groups
- 17 Suggest an aim, objectives and learning outcomes for an interactive piece of work with a target group exploring social justice issues
- 18 Develop a plan of practical work for a specific target group to include individual and group resource needs and appropriate methods and techniques for working the target group
- 19 Reflect on own practice and competency to incorporate social justice work in the relevant context and setting to include an individual personal

development strategy for dealing with social justice issues and a specific target group.

Assessment

General Information

Description

Project

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. 2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

The outcomes may relate to engaging in a specific activity, with the capacity to use the instruments and techniques relating to an occupation. They are associated with work being undertaken independently, subject to general direction.
