Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to design and build pneumatic circuits and to work on pneumatics systems safely and competently under supervision.
Learning Outcomes	Learners will be able to: 1 Describe key principles and concepts involved in pneumatics including Pascal's Law, force, pressure and area relationships, causes of pressure, work and power, compressibility, weight, and mass 2 Outline the safety considerations relating to the use of pneumatic power such as the correct use of compressed air, the depressurisation of circuits and the securing of all fittings, tubing, and connectors before connecting any pneumatic components or systems to a compressed air supply 3 Describe the construction, operation and effects of common valves, cylinders, regulators, receivers, filters, lubricators, silencers, compressors, dryers and

- moisture separators, oil conditioners and contamination separation equipment
- 4 Explain how force is transmitted by various common valves and cylinders found in pneumatic systems
 - 5 Describe the impact of temperature in a pneumatic circuit, including the cooling and lubrication requirements of compressors
 - 6 Use pneumatic equations to perform common calculations such as pressure drop, force and work
 - 7 Draw and interpret common component symbols within pneumatic circuit drawings, including the identification of the condition of control valve set-ups compared to the control diagram
 - 8 Create a range of pneumatic circuits containing compressed air using common cylinders and valves, from design through to build
 - 9 Diagnose pneumatic circuit component failures replacing components as required
 - 10 Demonstrate preventative maintenance tasks including the assembly, charging and checking of accumulators and control valves
 - 11 Plan a maintenance procedure on a production machine, with emphasis on accurate record keeping.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. In exceptional circumstances providers may identify alternative assessment techniques through the provider's application for programme validation which are **reliable** and **valid** but which are more appropriate to their context.

Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

Group or team work may form part of the assessment, provided each learner's achievement is separately assessed.

Assessment Techniques

In order to demonstrate that they have reached the standards of knowledge, skill and competence identified in all the learning outcomes, learners are required to complete the assessment(s) below.

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and FETAC's assessment requirements.

Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

The assessor will devise a skills demonstration based on learning outcomes 7 to 11.

Examination - Theory

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.

The assessor will devise a theory based examination based on learning outcomes 1 to 6.

Recognition of Prior Learning (RPL)	Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Access	To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.	
Transfer	Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.	

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Learning outcomes at this level include a broad range of skills that require some theoretical understanding. The outcomes may relate to engaging in a specific activity, with the capacity to use the instruments and techniques relating to an occupation. They are associated with work being undertaken independently, subject to general direction.
