Title Race Horse Care and Exercise

Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to work in the horseracing industry, caring for racehorse before, during and after a race

meeting and exercise racehorses.

Learning Outcomes

Learners will be able to:

- 1 Recognise the benefits of teamwork within a stable, including the importance of communication and confidentiality
- 2 Outline the horse racing industry structure, including the training and licensing available for the various roles and the staff structure in a racing stables
- 3 Explain the security procedures and drug testing procedures at race meetings, including the reasons for the procedures, the importance of time keeping and the documentation required for the groom and horse
- 4 Discuss aspects of exercising a racehorse including suitable and unsuitable surfaces, appropriate safety

procedures for riding in groups and the signs of fitness, stress and injury in horses after exercise or racing

- 5 Prepare a racehorse correctly and efficiently for exercising including selection and fitting of personal equipment and clothing, horse equipment including brushing boots, mounting up, adjusting girth, stirrups and quarter sheet while mounted
- Demonstrate walk, trot and canter on a range of quiet racehorses in company, in single file and upsides according to instructions, maintaining correct balance, position and control of the horse, identifying the correct canter lead and displaying correct pace and distance when in company
- 7 Demonstrate riding safely on roads with regard for potential hazards and horse's reactions
- 8 Provide alternative forms of exercise to a broken horse including selecting and fitting the appropriate equipment for the rider and the horse, safely carrying out each task, at walk and trot
- 9 Prepare a horse for travel including checking the vehicle for safety and loading and unloading the horse
- 10 Demonstrate correct procedures for leading up at a race meeting, including the preparation of the horse for the races
- 11 Demonstrate interpersonal skills in a working environment including dealing with conflict, taking orders and following instructions
- 12 Plan personal goals and targets and future career plans within the work environment.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. In exceptional circumstances providers may identify alternative assessment techniques through the provider's application for programme

Description

Assignment

An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A

skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), http://www.nfq-qqi.com. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
