##### 1. Component Details

<b>Title</b>	Sport Horse Riding
<b>Teideal as Gaeilge</b>	Marcaíocht ar Chapall Spóirt
<b>Award Class</b>	Minor
<b>Code</b>	5N3359
<b>Level</b>	5
<b>Credit Value</b>	30
<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to ride an experienced horse in an enclosed space without assistance.
<b>Learning Outcomes</b>	<p>Learners will be able to:</p> <ol style="list-style-type: none"><li>1 Discuss the application of correct aids for canter leads and school figures</li><li>2 Explain the Training Scale</li><li>3 Examine the riding horse with regard to outline, obedience and responses</li><li>4 Explain basic dressage figures and their use in the training of the horse to include loops and serpentine, turns and circles and leg yield</li><li>5 Interpret the rules of the road and road signs, and potential hazards when riding a horse on a road</li><li>6 Explain the five phases of the jump</li></ol>

- 7 Explain jumping distances for basic training to include trotting poles, placing poles and simple grid work distances
- 8 Specify procedures to be followed in the event of an accident
- 9 Lead a tacked up horse in hand, trot him up and show him as if for purchase
- 10 Check tack for fitting and soundness
- 11 Mount and dismount a schoolmaster
- 12 Adjust stirrups for various disciplines whilst mounted and tighten girth
- 13 Demonstrate correct basic riding position on a quiet horse showing appropriate independent balance, suppleness, depth of seat and security of position in all three paces
- 14 Demonstrate the application of correct aids for canter leads and school figures to include loops and serpentines, turns and circles
- 15 Ride without stirrups showing balance security and harmony in walk, trot and canter
- 16 Evaluate the riding horse's way of going with regard to the Training Scale
- 17 Demonstrate a correctly balanced position through a grid and over a course of fences on an experienced horse using appropriate rein length and contact, correct stirrup length and ability to use the lower leg showing fold and follow over the fence
- 18 Jump in harmony a quiet experienced horse showing correct lines of approach and get away around a course of fences to a maximum of 2.6 or 80cm
- 19 Ride an experienced horse in the open and adopt a safe procedure throughout
- 20 Ride a horse on a simulated public road complying with road safety requirements including correct clothing and tack and appropriate hand signals
- 21 Work responsibly when handling and riding horses taking account of personal safety, safety of the team and safety of the horses during all skill procedures.

## **Assessment**

## General Information

## Description

### Skills Demonstration

*A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.*

### **Examination - Theory**

*An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.*

*A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.*

### **Recognition of Prior Learning (RPL)**

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. ### **Specific Validation Requirements**

The provider must have all of the following in place to offer this award:

1. Access to a yard that is approved by the Association of Irish Riding Establishments ([www.aire.ie](http://www.aire.ie))
2. Various types of trained and experienced horses, suitable for training students to ride at Level 5 both on the flat and over fences
3. Tack that is safe and suitable
4. Closed arena with a safe surface
5. Facilities and equipment to put up a full show jumping course
6. Facilities for training over cross country fences

### **Access**

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

## Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

## 2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
