Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to apply the basic principles of instruction using a constructive lesson plan under supervision to improve horsemanship of a novice rider.
Learning Outcomes	<p>Learners will be able to:</p> <ol style="list-style-type: none">1 Explain the safety procedures and principles involved in the organisation of lessons and hacks2 Investigate possible hazards in equine instruction and the necessary actions to avoid them3 Discuss procedures in the event of an accident4 Discuss the components of a code of practice for coaching which ensures high standards of conduct are maintained5 Discuss basic training techniques of the horse and rider taking account of the rider's physiological and psychological needs

- 6 Discuss the basic records necessary in a commercial riding establishment
- 7 Comment on the importance of effective client care dealing with a range of situations to meet their needs and expectations
- 8 Design a lesson plan for a class lesson for novice riders
- 9 Construct risk analyses of activities including facilities, riders and horses
- 10 Assess the riding level of the clients
- 11 Execute a class lesson to suit novice riders
- 12 Employ the necessary skills to conduct a safe and educational class lesson for a novice rider showing improvement
- 13 Analyse the performance of horse and rider
- 14 Provide feedback and an action plan to the riders in the lesson
- 15 Deliver a ten minute oral presentation confidently and fluently to novice riders on an appropriate aspect of stable and yard routine
- 16 Take responsibility for own learning through evaluation of own performance and learning in a learning diary
- 17 Assume responsibility for safety and welfare of riders and horses during all skill procedures
- 18 Exercise some initiative and independence in carrying out coaching activities.

Assessment

General Information

Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Examination - Theory

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. 2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
