Title	Sterilisation and High Level Disinfection

Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to implement sterilisation and high level disinfection practices in a health services environment.
Learning Outcomes	<p>Learners will be able to:</p> <ol style="list-style-type: none">1 Summarise a range of inspection techniques including visual tests, residual protein-testing, electrical testing, damage and functionality testing and describing the assembly method of sets2 Discuss the importance of a stock control system in the decontamination facility, to include record keeping, completing decontamination certificates and tracking and tracing surgical instruments sets through the sterilisation process to the patient3 Demonstrate a comprehensive knowledge of sterilisation procedures and practice, to include how sterilisation fits into the decontamination process, an outline of where sterilisation takes place and a description of an independent monitoring system

- 4 Examine the clean room environment to include the dress and behaviour protocols, the inspection process and techniques
- 5 Examine a range of storage systems, to include their design and features, the advantages of different types, the importance of appropriate staff behaviour in handling and storing medical devices, the function of sterile and raw materials store and the factors that compromise sterile stock
- 6 Differentiate between the different types of sterilisers, their uses and method of operation, while being aware of sterilising parameters
- 7 Implement a range of requirements of an inspection environment to include completing the relevant documentation detailing the inspection process, sources of contamination, ventilation, personnel and raw material
- 8 Demonstrate knowledge of the functions of a flexible endoscope, its make-up and the methods used to process the different parts, to include how it can become contaminated, the procedures for pre-cleaning, testing for leaks, manual cleaning, disinfection and decontamination
- 9 Implement packaging procedures for sterilisation in high level disinfectant practice to include the method of maintaining a packaging work station and the requirements for packaging materials, rigid and flexible packaging, labelling and heat sealing
- 10 Prepare medical devices for repair to include the completion of relevant documentation.

Assessment

General Information

The techniques set out below are considered the optimum approach to assessment for this component. Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and FETAC's assessment requirements.

Description

Assignment

An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.

The assessor will devise two assignments worth 20% each

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Specific Validation Requirements

The provider must have all of the following in place to offer this award:
Access to an up to date decontamination facility including packaging, sterilising, disinfection, storage, records and endoscopy equipment.

Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

The outcomes may relate to engaging in a specific activity, with the capacity to use the instruments and techniques relating to an occupation. They are associated with work being undertaken independently, subject to general direction.
