Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to understand the process of creative writing, the key aspects of writing fiction and the process

of publication.

Learning Outcomes

Learners will be able to:

- 1 Explain the concept of showing not telling in writing
- Explore the purpose, language and idioms of a character
- 3 Summarise structure and plot development to include the different possibilities for plotting a story, timelines in relation to the narrative and point of view
- 4 Discuss a range of different writing genres and the limitations of the worlds that writers create
- 5 Examine the process of getting work published in Ireland and abroad to include the role of agents and publishers and self publishing

- 6 Use a range of writing skills to include researching ideas from a range of sources, recording ideas in a notebook, using grammar to alter the narrative and revising and editing work
- 7 Employ the skill of characterisation to include the creation of a range of believable characters, showing feelings and emotions through words and actions, creating dialogue that comes from the character, identifying if the narrator is present or omnipresent and determining the history of a character
- 8 Write in the first, second and third person
- 9 Construct different ways of telling the same story to include flash forward and flash back
- 10 Use language to set the tone of the narrative and create a strong sense of place
- 11 Present work for an agent or publisher which is correctly laid out according to industry practice
- Produce a variety of written pieces of work, which range in content and length
- 13 Use structure and plot development to create intrigue for the reader
- 14 Employ setting and atmosphere to include the use of real locations as the source for fiction and the creation of clothes and costumes that are unique to the story
- 15 Source a variety of agents and publishers in Ireland
- 16 Critique their own work and the work of others.

Assessment

General Information

Description

Project

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or

may involve process such as a design task, a performance or practical activity or production of an artefact or event.

Assignment

An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. 2. FET Award Standards

Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.nqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
