Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to Open Canoe safely and competently on Grade II rivers and to enable the learner to provide introductory Open Canoe instruction to a group of up to six participants in a sheltered flat water static site location.
Learning Outcomes	<p>Learners will be able to:</p> <ol style="list-style-type: none">1 Discuss the role of the instructor in the planning and delivery of a canoeing session2 Explore an appropriate teaching model for canoeing instruction3 Summarise the potential dangers in the canoeing environment to include, moving rivers, inland lakes and sheltered tidal estuaries4 Explore a range of communication skills and signals appropriate to the environment5 Discuss the natural environment, how to reduce the potential impact canoe sports can have on it and the

conflicts of interest that can arise between different water users

- 6 Explore the purpose and use of Open Canoeing equipment appropriate for use on flat water static sessions to a group
- 7 Select appropriate equipment for Open Canoeing in a Grade II environment as a member of a group and for instructing flat water static sessions
- 8 Execute a range of paddle strokes and techniques solo, to include; forward and reverse strokes, j stroke, sweeps, edging, rudders, draws, prys, pivot turns and support strokes for use on grade II moving water
- 9 Demonstrate the ability to paddle moving water using river features to best advantage to include; use of jets, eddy's, stopper and waves counteracting the effects of wind on your boat
- 10 Execute a capsize drill, standard-X and curl rescue, defensive and offensive swim, using a throw bag to rescue a swimmer, a deep water re-entry and a variety of tows
- 11 Implement a structured introductory session for up to six participants to include; briefing, warm-up, instruction, coaching, and debrief
- 12 Prepare a risk analysis and back-up plan prior to entering the water
- 13 Analyse a weather forecast and tidal information for the operating area
- 14 Maintain line of sight and communication with a group throughout a session by use of appropriate positioning
- 15 Analyse a session in terms of personal instructing performance, progress of participants and identifying improvements for successive sessions
- 16 Demonstrate a knowledge of first aid skills applicable to the canoeing environment.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A

skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

The outcomes may relate to engaging in a specific activity, with the capacity to use the instruments and techniques relating to an occupation. They are associated with work being undertaken independently, subject to general direction.
