Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to work under supervision and with others to carry out routine operations of ongrowing finfish.

Learning Outcomes

Learners will be able to:

- 1 Comment on why fish are starved prior to transfer
- Summarise the procedures used to help get juvenile fish off to good start after transfer to an on-growing facility
- Discuss the relative merits of different types of ponds, tanks, ropes, cages, moorings, nets, auto feeders, graders and water treatment systems used in aquaculture
- 4 Interpret the harvest code of practice
- 5 Explain the relevant quality and certification standards

- Discuss the importance of the disinfection routine prior to and post handling of Finfish
- 7 Review the relevant monitoring regulations and their enforcement bodies
- 8 Examine the affect of handling techniques during harvesting
- 9 Prepare a cage for fish transfer
- 10 Check mesh size and quality of nets
- 11 Record accurately details of fish transfer
- 12 Repair a damaged net/tank
- 13 Form the most common knots and splices used in aquaculture
- 14 Coil and uncoil correctly new and used ropes
- 15 Assist in a net change
- 16 Assist in filling of a feed barge
- 17 Comment on good feeding practices for ongrowing finfish
- 18 Carry out routine batch weights
- 19 Assist in sampling of condition factor and index
- 20 Plan a potential finfish farm to include preparation for licence application
- 21 Assist during harvesting
- 22 Assist in removing stock from a cage/tank
- 23 Interpret charts
- 24 Apply the principles of meteorology
- 25 Recommend the correct sea-lice treatment
- 26 Calculate stocking density, feed rate, food conversion ratio and treatment dosages
- 27 Handle chemicals correctly and safely and fill in a chemical log
- 28 Plan the procedure to deploy and adjust sea cage moorings

- 29 Plan a weekly/monthly/annual finfish farm work programme
- 30 Hand feed fish and feed using automatic feeders correctly
- 31 Identify the major threats to fish health
- 32 Exercise initiative in maintaining fish health.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Examination - Theory

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Specific Validation Requirements

The provider must have all of the following in place to offer this award:

Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
