Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to visually evaluate linear

conformation and movement relating to performance.

Learning Outcomes

Learners will be able to:

- Generate an advertisement of a horse for sale using visual media to include a description of the physical characteristics of the horse such as type, breed, performance record and pedigree, height, bone, age, colour, markings and sex
- 2 Estimate the effect the common conformation and gait defects and interferences may have on a horse's clinical soundness and performance
- 3 Evaluate the risks involved in handling horses and the importance of implementing safe working practices at all times
- 4 Use an inspection sheet to judge a selected horse for conformation, movement and athleticism as per regulatory body guidelines

- Judge mares on conformation taking into account pedigree, performance, and breeding purpose
- Judge the biomechanics of a horse jumping a fence when loose jumping
- Work responsibly taking account of personal safety and safety of the team during all skill procedures
- 8 Present to a peer group the static and dynamic conformational requirements necessary for competition horses to include show horse, showjumping, eventing, dressage and leisure horse such as hunting, riding club, pony club, riding school
- 9 Show self reliance for own learning in the context of assessing a variety of horses for conformation at sales shows both on the flat and over fences.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Examination - Theory

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. 2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. Occupations at this level would include higher craft, junior technician and supervisor.
