Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to effectively demonstrate arts

event management skills as part of a community of arts

practitioners.

Learning Outcomes Learners will be able to:

- Articulate a rationale for arts organisations and their unique services to the arts community and to public, cultural and civic life
- 2 Identify distinguishing features of diverse arts organisations, including public, private, voluntary, community
- 3 Explain the role of branding and mission for an arts organisation
- 4 Analyse factors which enable arts organisations to flourish, including socio-cultural, economic, political, effective leadership, management and communications strategies, location and accessibility

- 5 Analyse key issues in arts management, including audience development, political factors, funding and sponsorship, marketing, customer service, planning and logistics management, educational programming/mediation
- 6 Define arts products in the context of specific organisations
- 7 Identify a range of roles in arts event management, including curator, archivist, arts director, mediator, facilitator, invigilator
- 8 Identify ways of classifying and reaching diverse audience types, including for example attenders, adorers, adopters, intenders, indifferent, hostile
- Use project planning methodologies for an arts event, to include reference to mission, audience, stakeholder, vendor, patronage, budget, goals, sequencing, location, logistics, floor and display plan, security, marketing, front of house and ticketing, mediation, evaluation
- 10 Use a range of technologies effectively to market and promote strong public relations, including opening night, and strategic coherent directions for educational programming during an arts event
- 11 Manage as part of an event team the logistical concerns for specified arts events, including transportation, curation and protection of arts artefacts, packing and unpacking procedures, set-up and take down, lighting and display techniques
- 12 Use appropriate recording, documentary and archiving processes for arts events
- 13 Identify ways to promote sustainability and extend the impact of the event
- 14 Communicate effectively with event management team, supervisory management and stakeholders
- 15 Evaluate critically own and others performances in running an arts event.

Assessment

General Information

Description

Project

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

Portfolio / Collection of Work

A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.

Access

2. FET Award Standards

QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
