Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to practice fine art painting as a disciplined personal visual language to communicate expressively and to solve visual problems using a comprehensive range of media, with due regard for relevant theories, properties of media and health and safety requirements.

	1	Evaluate a comprehensive range of approaches to painting as an expressive and communicative language, including through a range of art movements
	2	Outline the advantages and disadvantages of different paint media including with reference to their historical development
	3	Locate own and others paintings in theoretical context using correct terminology

- 4 Explain the purpose and process for recording and cataloguing art works, including personal work
- 5 Explain colour theory with examples of expressive application
- 6 Use the language of art criticism
- 7 Prepare a variety of surfaces for paint, to include; stretching and priming canvas, watercolour papers, wood and plaster with gesso, and others as appropriate
- 8 Use a variety of traditional and experimental techniques, processes and surfaces, to include: oil, acrylic and watercolour paints to record and interpret a wide variety of surfaces
- 9 Use painting to visualize solutions and develop concepts including with reference to primary and secondary research materials to explore personally relevant visual concerns and for problem solving and design needs
- 10 Produce a coherent conclusive body of work to exhibition standard underpinned by appropriate research practices
- 11 Integrate cross disciplinary skills and knowledge in approaches to painting
- 12 Establish a process of drawing using personal ideas and motivations for personal practice
- 13 Exercise responsible workshop practice including with regard to planning, administration, health and safety and environmental concerns
- 14 Evaluate the quality of paintings including with regard to expressive impact, technical competence and or craft skill appropriateness of treatment and presentation.

### 2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <u>http://www.nfq-qqi.com</u>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see <u>www.qqi.ie</u>).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

### 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

#### Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
