<b>Title</b>	Body and Beauty Science and Treatments

<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence in the principles and practices underpinning body and beauty science and treatments to work autonomously and independently in carrying specialised body and beauty treatments to meet a range of client needs.
<b>Learning Outcomes</b>	<p>Learners will be able to:</p> <ol style="list-style-type: none"><li>1 Explain the key principles of physics to include heat, light, and sound waves</li><li>2 Apply the inverse square/cosine law to heat and light treatments</li><li>3 Classify basic chemistry to include matter, atoms, elements, bonding, chemical compounds and the pH scale</li><li>4 Explain a range of chemical terms and processes relevant to body and beauty products and treatments</li><li>5 Explain the role of solutions, suspensions, emulsions and colloids in beauty and body products</li></ol>

- 6 Evaluate the psychological and physiological effects of water on the body
- 7 Explain the properties and characteristics of water
- 8 Examine the functions, ingredients, properties and composition of commercial skin and body products
- 9 Evaluate the benefits, effects, indications, contra-indications, contra-actions and uses of a specialised massage technique
- 10 Assess the benefits and effects of a range of professional products for advanced skin and body treatments
- 11 Evaluate the benefits, effects, indications, contra-indications, contra-actions and uses of heat, light and specialised treatments on the face and body
- 12 Carry out consultations to identify suitable treatments and their objectives
- 13 Carry out any relevant tests required prior to treatments
- 14 Conduct and adapt a facial treatment, to incorporate specialised masks and active ingredients, to suit the client's needs within a commercially acceptable time limit
- 15 Conduct and adapt a hand and foot treatment to suit the client's needs within a commercially acceptable time limit
- 16 Conduct and adapt a body treatment to include heat treatments, exfoliation, masks and or wraps to suit the client's needs within a commercially acceptable time limit
- 17 Conduct and adapt a full body specialised massage treatment, to suit the client's needs within a commercially acceptable time
- 18 Conduct all treatments using professional products
- 19 Provide appropriate aftercare and homecare advice
- 20 Implement good practice with regard to health and safety guidelines when conducting treatments
- 21 Ensure the positioning of both client and therapist is correct for all treatments
- 22 Record and reflect on the results of treatments

- 23 Communicate and behave in a professional manner
- 24 Adhere to manufacturers' instructions for the use of professional products.

## Assessment

### General Information

## Description

### Assignment

*An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.*

### Examination - Theory

*An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.*

*A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.*

### Examination - Practical

*An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.*

*A practical examination assesses specified practical skills demonstrated in a set period of time under restricted conditions.*

## Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. ## Specific Validation Requirements

The provider must have all of the following in place to offer this award:

Access to body and beauty therapy work stations to include plinth, trolley, stool and magnified lamp

2. Access to sterilisation and sanitisation equipment

**Access**

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

**Transfer**

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

## 2. FET Award Standards

QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

### 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

### Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
