#### 1. Component Details

<b>Title</b>	Fabric Manipulation
<b>Teideal as Gaeilge</b>	Ionramháil Fabraice

<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to use fabric manipulation and stitch processes creatively and to interpret visual research for craft and design.
<b>Learning Outcomes</b>	Learners will be able to: <ol style="list-style-type: none"><li>1 Identify the categories of fabrics to include; manmade, natural and mixed fabrics</li><li>2 Use fabrics of various characteristics, properties and finishes to include; woven, knitted, non-woven, transparent</li><li>3 Explore a range of techniques that can be used to manipulate and stitch surface to produce fabrics suitable for one- off expressive pieces, or fabrics for fashion, interiors, or product</li><li>4 Interpret line qualities with a broad range of threads, yarns and trimmings with various textures</li></ol>

- 5 Use hand and machine stitch in decorative, functional and expressive ways taking information from qualities in drawing or from design
- 6 Carry out sample tests on a wide range of fabrics to demonstrate the effects of traditional and non-traditional manipulation techniques
- 7 Identify the suitability of fabrics for a given purpose
- 8 Collect visual examples of historical, contemporary and cultural uses of fabric manipulation and stitch in fashion and interior fabrics and accessories and in craft or textile art
- 9 Use the sewing machine as a creative tool for the translation of drawing and design into fabric and stitch
- 10 Use the sewing machine to explore techniques to include; appliqué, quilting, cord making and free embroidery
- 11 Apply correct health and safety procedures in the use of the sewing machine and other craft equipment
- 12 Produce craft or designed work that demonstrates the ability to integrate manipulated backgrounds with surface stitch
- 13 Create innovative surfaces relating to design research using a range of manipulation techniques to include; folding, deconstruction, drawn thread work, cutwork, gathering, pleating, smocking, slashing and fraying
- 14 Record the planning; preparation and making of finished work including a cost sheet
- 15 Finish and present work to a professional standard meeting the design brief, within planned timelines.

## **Assessment**

### **General Information**

## Description

### Portfolio / Collection of Work

## 2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see [www.qqi.ie](http://www.qqi.ie)).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

### 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

### Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
