Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to draught and present drawings related to the construction of buildings in accordance with specific standards.
Learning Outcomes	Learners will be able to: <ol style="list-style-type: none">1 Explore the methods of construction that use prefabricated building components and cast in situ elements2 Explore the general principals of drawing practice3 Examine how specification and working drawing documentation is assembled and produced4 Examine the need for concise wording when incorporating quantities of text5 Use the grid system as a datum for referencing modular structural members

- 6 Apply grid notation to layout plans, sections, elevations and construction details
- 7 Allocate an appropriate size to text and figured dimensions
- 8 Utilise the appropriate draughting conventions in a drawing
- 9 Arrange elements appropriately within the drawing space
- 10 Represent different elements by the selection of appropriate scales
- 11 Indicate setting-out and overall dimensions as well as standard abbreviations and symbols on drawings
- 12 Use a checklist to ensure the inclusion of draughting conventions and keep a record of tasks to be completed
- 13 Arrange all the information on the requisite number of drawings
- 14 Represent different construction materials and surface finishes
- 15 Assign the correct information to information panels, legends and with reference to orientation
- 16 Apply appropriate shadow and shading and use of colour rendering to drawings
- 17 Represent structural frames in concrete and steel
- 18 Incorporate the types of Level 3s used in buildings with prefabricated structural frames
- 19 Develop an acceptable standard of consistency and clarity in the production of final drawings
- 20 Produce a finished set of drawings and other associated documentation
- 21 Implement a procedure for making revisions to drawings.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. Description

Project

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may

involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

Portfolio / Collection of Work

A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.

Assignment

An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. 2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
