**Purpose** The purpose of this award is to equip the learner with the

knowledge, skill and competence to understand the principles and practices underpinning still life photography. It will enable the learner to explore the full potential of studio based and

location based still life photography.

## **Learning Outcomes**

Learners will be able to:

- Interpret a client¿s brief examining concepts and visual language
- Evaluate factors to be considered when planning photographic sessions using conventional and digital methods to include choice of camera, lens type and accessories, choice of image capture mode, lighting options, liaison with other personnel, health and safety and other legal considerations, cost, time scale and other practical implications
- 3 Describe approach to be taken to fulfil brief, providing a rationale for choices selected

- 4 Generate informed choices regarding suitability of various equipment for specific photographic sessions
- Demonstrate an understanding of specialist construction and lighting techniques for problematic subject matter like glass chrome etc
- Organise the studio environment for effective working, observing health and safety and other legal requirements
- 7 Use effectively light metering equipment with both flash and ambient light, to optimise image potential
- 8 Demonstrate a wide selection of approaches to Still Life Photography
- 9 Produce imaginative visual design solutions to a clients brief
- 10 Demonstrate a working knowledge of health and safety issues when in studio or on location
- 11 Experiment with a wide range of camera and lighting techniques to achieve specific visual effects
- 12 Prepare a portfolio of work suitable for presentation
- 13 Incorporate new techniques and processes into the creative process
- 14 Recognise the importance for effective research, time management and self evaluation.

## **Assessment**

### **General Information**

## **Description**

## **Project**

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

### Portfolio / Collection of Work

A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.

### Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. #### 2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

## **Guide to Level**

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
