Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to understand the history of photography including critical theory and semiotics and to enable deconstruction and comprehension of a diverse array of photographic styles, approaches, philosophies and individual

images.

Learning Outcomes Learners will be able to:

- Explain key developments in the history of photography
- 2 Formulate a critical understanding of particular movements and approaches in photography and their evolution in line with changing social, political, cultural and economic conditions
- 3 Identify issues around the politics of representation including contemporary photographic dilemmas and debates
- 4 Evaluate some of the parallels between photography, filmmaking and the visual arts

- 5 Describe the relevance and intention of a range of key critical theory texts
- 6 Critically evaluate personal practice relating it to specific histories and theoretical debates
- 7 Explain the function and reading of photography in contemporary society
- 8 Describe how technological innovation has influenced the practice of photographers working within selected genres
- 9 Appraise basic principles of semiotic theory
- 10 Summarise the work of individual practitioners who have pioneered specific approaches to photography
- Work both independently and as part of a research team in a disciplined professional manner
- 12 Appreciate the need for planning, research, time management and self evaluation techniques.

Assessment

General Information

Description

Project

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

Assignment

An assignment is an exercise carried out in response to a brief with specific guidelines as to what should be included. An assignment is usually of short duration and may be carried out over a specified period of time.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Access

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), http://www.nfq-qqi.com. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.nqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
