#### 1. Component Details

<b>Title</b>	Jewellery Making

<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to make original jewellery, including setting stones within small scale fabrication, with regard for design principles and the relationship between form and function.
<b>Learning Outcomes</b>	<p>Learners will be able to:</p> <ol style="list-style-type: none"><li>1 Identify the features of a range of appropriate materials, metals stones, tools, techniques and underpinning craft skills in jewellery making</li><li>2 Outline budgeting process, environmental and health and safety issues in using metals and materials in a jewellery making context</li><li>3 Explain the impact of ergonomics, form and function on design for jewellery</li><li>4 Use a variety of metal cutting, forming and finishing techniques, including hammering, rolling, soldering and joining</li></ol>

- 5 Set stones of different sizes and cuts including faceted and cabochon stones
- 6 Interpret primary and secondary source material in the light of metals, stones and jewellery making traditions
- 7 Use design principles and elements consciously and experimentally in preparing for jewellery making
- 8 Present original designs for jewellery demonstrating regard for ergonomic considerations, the relationship of form with function, the nature of the brief and of the materials chosen within solutions
- 9 Exploit a range of experimental treatments of metals within design solutions
- 10 Produce finished jewellery including correctly set stones, underpinned by research and interpretation and relevant test pieces
- 11 Compile a body of primary research into technical dye craft skills that are relevant to a coherent body of personal work in design for jewellery making
- 12 Exercise responsible workshop practice including with regard to planning, costing, workshop health and safety and environmental concerns
- 13 Demonstrate critical awareness of own and others technical craft skills in the context of contemporary and past jewellery making practice

## Assessment

### General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

## Description

### Project

*A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.*

### Portfolio / Collection of Work

*A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.*

<b>Recognition of Prior Learning (RPL)</b>	Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. <b>Supporting Documentation</b>	None	
<b>Access</b>	To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.	
<b>Transfer</b>	Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.	

## 2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see [www.qqi.ie](http://www.qqi.ie)).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

### 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

### Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
