<b>Purpose</b>	The purpose of this award is to equip the learner with the knowledge, skill and competence to work successfully in airport passenger and to develop effective station management skills.
<b>Learning Outcomes</b>	Learners will be able to:  <ol style="list-style-type: none"><li>1 Summarise the key factors that influence the development of the aviation industry</li><li>2 Analyse the products and services that Irish and U.K. airlines offer</li><li>3 Examine Travel Insurance policies and terms and conditions of sales</li><li>4 Evaluate the range of socio-political factors to which the Travel and Tourism Industry is vulnerable</li><li>5 Examine the duties and responsibilities of air traffic control</li></ol>

- 6 Research the Special Service Requirements codes (SSR)
- 7 Explore ways to identify and deal with issues passengers may have and difficult situations
- 8 Investigate the factors which can influence the success of a passenger service team to include different leadership styles that would benefit a station supervisor
- 9 Explain the five classifications of fire and the procedures that should be followed in the event of discovering a fire
- 10 Identify the categories and classifications of Dangerous Goods and the regulations pertaining to their carriage
- 11 Assess the importance of Security Regulations to include the regulations laid down by the European Commission regarding prohibited items
- 12 Identify the roles of the principal services involved in air and ground operations to include the classes of equipment used to enable an airport to operate in a safe and efficient manner
- 13 Use the travel information manual and data systems to extract information on passport, visa and health regulations applicable to air passengers
- 14 Identify the key elements associated with check-in procedures and examine airlines excess baggage charges
- 15 Evaluate the working conditions associated with the role of a passenger service agent
- 16 Perform pre-flight check-in duties and a manual check-in for different categories of passengers to include creation of booking files
- 17 Perform boarding duties and procedures
- 18 Carry out appropriate safety and health procedures in accordance with own role and organisational requirements

- 19 Practice the key competencies required to work efficiently in a passenger services position
- 20 Practice the competencies necessary to provide excellent customer service to all types of passengers, including those from different cultural backgrounds
- 21 Carry out the duties of an effective station supervisor to include managing an effective passenger service team.

## **Assessment**

## Description

### Skills Demonstration

*A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.*

### Examination - Theory

*An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.*

*A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.*

## Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI’s website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

## 3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

### Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
