Purpose The purpose of this award is to equip the learner with the

knowledge, skill and competence to explore and apply the principles of computer animation, graphics, navigation theory and interactive website design and to formulate a range of creative processes for the production of content using graphics

and animation techniques.

- 1 Asses a range of file formats and file types
- 2 Explore navigation theory and the application of common HTML tags
- 3 Appraise a range of colour codes
- 4 Assess the difference between vector and bitmap graphics
- 5 Ulitise frames, keyframing, motion, colour and shape tweening
- 6 Add sound to an animation

- 7 Create interactive buttons with assigned actions on a web site
- 8 Control animation and sound with play and stop buttons
- 9 Manage events to include organising event handlers and controling timeline events
- 10 Create scrollable dynamic text to include the use of input text fields
- 11 Utilise a range of video functions to include importing, controlling and editing
- 12 Employ a storyboard to develop a 2D animation
- 13 Create an interactive navigation menu to include an interactive pop-up menu
- Manage a range of animation functions to include publishing, exporting and optimising content

- 16 Produce an interactive slideshow
- 17 Develop a frame-by-frame animation.

Assessment

2. FET Award Standards

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated

authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. Occupations at this level would include higher craft, junior technician and supervisor.
