Purpose	The purpose of this award is to equip the learner with the knowledge, skills and competences to instruct novice participants in white water surfing skills.
Learning Outcomes	Learners will be able to: <ol style="list-style-type: none">1 Describe how the National Governing Body, Irish Surfing Association is governed and how its instructor training and skills awards are structured2 Demonstrate a comprehensive knowledge of technical white water surfing skills3 Identify how to develop and instruct these white water surfing skills appropriate to the context and the participants accommodating different types of learners4 Outline the Surf Instructor's role in the context of the activity, participants, peer instructors and the club or centre

- 5 Demonstrate knowledge of how to plan a safe surf session and general safe surfing, to included recommended 1:8 ratio and knowledge of Surf School Operation regulations
- 6 Discuss the impact of surfing on the environment, promotion of good practice and protection of our surfing environment and the impact of that environment on surfing
- 7 Demonstrate personal proficiency in surfing consistent with the National Governing Body requirements
- 8 Implement session plans appropriate to novice surfers and in a quality and safe learning environment
- 9 Apply communication skills appropriate to the context and the participants
- 10 Apply skills of observation, analysis and provision of feedback
- 11 Adapt to changing circumstances
- 12 Apply progressions to a skill/activity
- 13 Plan and conduct an assessment of participants
- 14 Instruct white water surfing skills using a structured teaching method
- 15 Manage and minimise risk while delivering the activity and practise appropriate safety procedures and techniques
- 16 Demonstrate effective and safe group management
- 17 Implement appropriate First Aid and emergency procedures
- 18 Demonstrate strategies to manage the impact of the environment on the session and the impact of the session on the environment
- 19 Adopt an ethical, non-discriminatory and all-inclusive approach to instructing
- 20 Evaluate a session in terms of personal instructing performance and progress of participants, identifying implications for successive sessions.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

Group or team work may form part of the assessment, provided each learner's achievement is separately assessed.

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and FETAC's assessment requirements.

Description

Skills Demonstration

A skills demonstration is used to assess a wide range of practical based learning outcomes including practical skills and knowledge. A skills demonstration will require the learner to complete a task or series of tasks that demonstrate a range of skills.

Learner Record

A learner record is the learner's self-reported and self-reflective record in which he/she describes specific learning experiences, activities, responses and skills acquired.

Recognition of Prior Learning (RPL)

Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. See RPL Guidelines at www.fetac.ie for further information and registration details.

Specific Validation Requirements

The provider must confirm they have approval from the National Governing Body, Irish Surfing Association, before offering programmes leading to this award.

Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it

makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Guide to Level

Learning outcomes at this level include a comprehensive range of skills which may be vocationally-specific and/or of a general supervisory nature, and require detailed theoretical understanding. The outcomes also provide for a particular focus on learning skills. The outcomes relate to working in a generally autonomous way to assume design and/or management and/or administrative responsibilities. Occupations at this level would include higher craft, junior technician and supervisor.
