4.6 Initial Validation

4.6.1 Cater Care Limited

The Committee NOTED the documentation circulated. Cater Care Limited applied to become a provider of programmes leading to FET awards made by QQI. It completed Stage 1 and was approved by the Approvals and Reviews Committee (ARC) on 3 November 2014 to move to Stage 2 of the process.

The Committee APPROVED the Initial Validation of three programmes, one leading to a minor award at Level 4, and two leading to minor awards at Level 5. It was NOTED that the Cater Care Ltd application represents the first complete application successfully through the QQI initial access policy. The Executive will inform the Board of this.

9.1 Request from ETBI for an extension to the deactivation dates for two awards
