4.1.3 Further Education and Training (FET) Programmes – Pilot Evaluation

The Committee NOTED the documentation circulated. The Committee NOTED that this was the first non-apprenticeship FET programme to be submitted for validation under the 2016 validation policy. Seven ETBs were involved, with Dublin and Dún Laoghaire ETB leading the curriculum development process. The shareable curriculum, developed with the involvement of all seven providers, will be used by each of the participating ETBs in their delivery of the programme. There may, however, be variation among providers in respect of the programme's implementation.
