Purpose	The purpose of this award is to equip the learner with the knowledge, skill and competence to use metalwork tools and equipment safely whilst under supervision and to research, plan, design and carry out basic metalcraft assignments.
Learning Outcomes	Learners will be able to: 1 Explain the uses of a range of metalcraft handtools to include tools for measuring, marking out, drilling, cutting, tapping, screwing and benchwork, electric powered hand tools to include hand drills, buffers and nibblers, and machine tools to include pedestal drills, lathes, machine powered saws and welders 2 State the characteristics of a range of materials and finishes used in metalcraft 3 Outline the basic properties of a range of materials to include steel, plastics, brass, copper and lead 4 Use a range of metalcraft techniques to include marking-out, drilling, cutting, bending, shaping, hot and cold joining and assembly

- 5 Operate a range of tools used in metalcraft to include hand tools, electric powered hand-tools and machine tools
- 6 Carry out a range of preparation and design tasks to include compiling a materials requirement list for specific tasks, selecting the correct materials for specific tasks, outlining the design process, interpreting a design brief with the aid of sketches and producing design solutions and work schedules for specific tasks
- 7 Identify a range of uses for materials and various types of finishes
- 8 Apply suitable preparations and finishes for specific tasks
- 9 Select appropriate tools and equipment and metalcraft techniques for specific tasks
- 10 Operate hand and machine tools in a work setting with due regard for the safety of self and others to include the identification of potential safety hazards, the correct usage of metalcraft tools and equipment and the correct use of personal protective equipment (PPE)
- 11 Maintain a range of tools, power tools and equipment to include an evaluation of their condition before use
- 12 Exercise proper procedures when cleaning and storing tools and equipment after use.

Assessment

General Information

All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence.

The techniques set out below are considered the optimum approach to assessment for this component. In exceptional circumstances providers may identify alternative assessment techniques through the provider's application for programme validation which are **reliable** and **valid** but which are more appropriate to their context.

Assessment of a number of components may be integrated across programmes for delivery, provided that the learning outcomes of each minor award are assessed.

Group or team work may form part of the assessment, provided each learner's achievement is separately assessed.

Assessment Techniques

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and FETAC's assessment requirements.

Description

Project

A project is a response to a brief devised by the assessor. A project is usually carried out over an extended period of time. Projects may involve research, require investigation of a topic, issue or problem or may involve process such as a design task, a performance or practical activity or production of an artefact or event.

Portfolio / Collection of Work

A portfolio or collection of work is a collection and/or selection of pieces of work produced by the learner over a period of time that demonstrates achievement of a range of learning outcomes. The collection may be self-generated or may be generated in response to a particular brief or tasks/activities devised by the assessor.

Recognition of Prior Learning (RPL)	Learners may be assessed on the basis of their prior knowledge and experience. Providers must be specifically quality assured to assess learners by this means. To do so they must complete B10, see Provider's Quality Assurance Guidelines and be included on the Register of RPL approved providers. Access	To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.	
Transfer	Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.	

2. FET Award Standards

QQI award standards are determined within the National Framework of Qualifications (NFQ), <http://www.nfq-qqi.com>. QQI determines standards for the education and training awards that it makes itself and that are made by providers to whom it has delegated authority to make an award. Providers offering programmes leading to QQI awards **must** have their programme(s) validated in accordance with current validation policy (see www.qqi.ie).

Award standards are designed to be consistent with the NFQ's award classes i.e. major, special purpose, supplemental and minor awards. They are expressed in terms of **learning outcomes** i.e. concise statements of what the learner is expected to know or be able to do in order to achieve a particular award. Learning outcomes for FET awards are contained within the associated specifications:

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.
