| Purpose | The purpose of this award is to equip the learner with the knowledge, skill and competence to provide an upstyle, wig, hairpiece or hair extension service for a client using relevant equipment and styling products. |
| Learning Outcomes | Learners will be able to: <ol style="list-style-type: none">1 Examine influencing factors when choosing a hair upstyle, wig, hairpiece and hair extensions, to include head and face shape, hair length, texture and growth patterns2 Discuss the effects of the environment, and hair and scalp diseases and disorders, on hair upstyle, wig, hairpiece and hair extensions3 Examine contra indications which may prevent a client from using a wig, hairpiece or hair extensions4 Examine dressing and upstyling hair to include, dry setting for volume, vertical french pleat, hair twists and plaits |

- 5 Describe wig and hair piece styling to include wrapping of hair prior to wig fitting, wig and hairpiece types, securing and styling
- 6 Describe hair extensions to include types, securing and styling
- 7 Employ professional standards when preparing a client for a salon service
- 8 Use a variety of combs, brushes, grips, pins, and hair ornamentation when carrying out an upstyle
- 9 Demonstrate sectioning, controlling, positioning and securing hair
- 10 Demonstrate dressing hair using different combing and back brushing and preparation techniques to include dry setting, french pleating, hair twists, plaits and bridal hair
- 11 Demonstrate a range of methods of wrapping hair prior to wig fitting, securing wig, hairpiece or hair extensions to include the use of glue, clip and weft extensions
- 12 Examine the balance and symmetry of the style, wig fitting or hair extensions regularly
- 13 Apply styling products to support, enhance and finish the upstyle, plait, hairpiece or hair extensions
- 14 Design a suitable upstyle, hairpiece or hair extension for a client using relevant products, equipment and techniques
- 15 Use ornamentation and finishing products effectively to complete the upstyle, hairpiece or hair extension
- 16 Employ safe practices on the hair and scalp when working with glue, clips, pins, grips and ornamentation.

Assessment

General Information

All assessment should be planned in accordance with the programme assessment strategy developed as part of the programme submission for validation. All FET assessment is criterion referenced. Successful achievement of the award is based on learners attaining the required standards of knowledge, skill or competence consistent with the **minimum intended programme learning outcomes**.

Assessment Techniques

The assessor is responsible for devising assessment instruments (e.g. project and assignment briefs, examination papers), assessment criteria and mark sheets, consistent with the techniques identified below and QQI's assessment requirements.

Programme validation will require providers to map each learning outcome to its associated assessment technique. All learning outcomes **must** be assessed and achieved in accordance with the **minimum intended module learning outcomes** set out in the validated programme.

Description

Examination - Theory

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A theory-based examination assesses the ability to recall, apply and understand specific theory and knowledge.

Examination - Practical

An examination provides a means of assessing a learner's ability to recall and apply knowledge, skills and understanding within a set period of time and under clearly specified conditions.

A practical examination assesses specified practical skills demonstrated in a set period of time under restricted conditions.

Access

To access programmes leading to this award the learner should have reached the standards of knowledge, skill and competence associated with the preceding level of the National Framework of Qualifications. This may have been achieved through a formal qualification or through relevant life and work experience.

Transfer

Successful completion of this component award enables the learner to transfer to programmes leading to other certificates where this component is a mandatory or an elective requirement.

2. FET Award Standards

Award standards are thresholds, they describe standards of knowledge, skill or competence to be acquired, and where appropriate, demonstrated, by a learner before an award may be made.

Award standards will be reviewed from time to time as necessary. Minor changes may be made by the QQI executive outside the review cycle where necessary. Changes to standards are published on QQI's website. Providers with validated programmes and providers with delegated authority to make awards are responsible for monitoring relevant standards and making necessary responses to changes.

3. FET Credit

Every FET certificate and component specification includes an FET credit value (Table 1). FET credit is quantified in multiples of 5 FET credits (up to 50 hours of learner effort). Learner effort is based on the time taken by typical learners at the level of the award to achieve the learning outcomes for the award. It includes all learning time involved including: guided learning hours, self-directed learning and assessment.

Guide to Level

Learning outcomes at this level include a broad range of skills that require some theoretical understanding. The outcomes may relate to engaging in a specific activity, with the capacity to use the instruments and techniques relating to an occupation. They are associated with work being undertaken independently, subject to general direction.
